STAR EXEMPTIONS: (425)

School Tax Relief

Basic & Enhanced STAR

After March 2, 2016, as a result of recent law changes, the STAR program is being reconstructed. NYS has decided that the Tax & Finance Department will administer any New STAR applications, taking the duty from your local assessor. Instead of the STAR Exemption being deducted from your school tax bill, you will have to pay your FULL school tax bill and will receive the STAR benefit in the form of a check.

Please be advised that you may want to contact your escrow account to verify the correct school tax withholdings.

To be eligible for a STAR check, you must register with the New York State Tax Department by:

School &/or County Tax Relief

- 1) Must be Owner-Occupied/Primary Residence
- 2) Copy of Deed
- 3) Must be 65 during the Calendar Year
- 4) Proof of age
 - a) Driver's License
 - b) Birth Certificate
- 5) Proof of Income
- 6) Exemption Reduction Ranges from 5-50% Based on Income
- 7) Must Renew Annually

DISABILITY EXEMPTION:

County Tax Relief

- 1) Must be Owner-Occupied/Primary Residence
- 2) Copy of Deed
- 3) No Age Requirements
- 4) Proof of Income
- 5) Documents of Disability
- 6) Exemption reduction Ranges from 5-50% Based on Income
- 7) Must Renew Annually
